

With the help of almost 200 golfers, Walton EMC employees are once again making a large contribution to help local young people.

The sold-out Spring Golf Classic includes the tournament itself, a silent auction and other contests that raise funds to make quality developmental programs available to the community's young people. The annual event is held at The Georgia Club in Statham.

With this year's \$43,000, employees have raised \$274,000 over the tournament's 10-year history for the **Walton County Boys and Girls Club.**

"The Boys and Girls Club provides recreation, companionship and educational programs that keep young people off the streets," said Ronnie Lee, Walton EMC CEO. "We're proud to support this quality organization that points our youth in the right direction."

"One of the cooperative principles we operate by is 'concern for community," said Walton EMC's Kathy Ivie, who coordinates the event. "But Walton EMC employees don't consider doing this a chore. It's something we love."

Notice: Patronage Capital Assignment for 2016

Margins in the amount of \$22,877,262.26 (approximately 8.84 percent of electric revenue) have been assigned to all patrons of record in 2016 on the basis of electric revenue.

Although margins earned are assigned to patrons each year, the cooperative uses these margins to repay principal on long-term debt and as capital to construct or purchase electric plant until a general refund can be made without impairing the cooperative's financial condition.

General refunds are made on a combination of first in/first out and last in/first out basis. This means a general refund will come partly from the oldest and partly from the most recent margins earned by the cooperative. The cooperative's bylaws permit the board to make special refunds to estates of deceased patrons.








AVERAGE NUMBER OF MEMBERS







Assets are the things Walton EMC owns buildings, equipment, poles, transformers, substations, power plants and everything else it takes to deliver your electric service.


AVERAGE MONTHLY RESIDENTIAL/FARM BILL

AVERAGE KWH PER MONTH




This is the amount of electricity the average customer-owner used per month.

This is what Walton EMC pays for wholesale power to meet the needs of its customer-owners.





TYPE OF ACCOUNTS




SOURCES OF REVENUE 2016



HOW ELECTRIC **REVENUE WAS USED IN 2016**

This is how we spend the money we receive. Most is used to buy power and operate the co-op. Less than 10 percent is spent on administration.



CAPITAL CREDITS RETURNED

2016 \$6,335,000 ALL TIME TOTAL \$87,571,000

Capital credits are what's left over after all bills are paid. In a co-op, that's called margins. Margins are used to pay down debt, make capital improvements and prepare for emergencies. When the co-op's board determines that our reserve is more than needed, the excess is returned.

Twice yearly, the Georgia Public Service Commission conducts a rate survey with all 94 of the state's electric utilities. The level of use for this comparison is a monthly use of 2,000 kilowatt-hours.
