# Scammers Are Targeting YOU

It's heartbreaking.

All too often, we hear of a Walton EMC customerowner who falls prey to a scammer's criminal activity. The victim's losses can be significant, costing hundreds or even thousands of dollars.

Common threads to most utility scams:

- Phone calls requiring urgent action
- Prepaid cash cards



#### **URGENT PHONE CALLS**

Your co-op will never call you threatening immediate disconnection. If you're called stating your electric service will be cut off if you don't follow specific instructions, hang up! If you're still in doubt, call us at 770-267-2505.

The time from receiving an electric bill to disconnection for nonpayment is at least 45 days. You'll also get a disconnection notification on the next bill before we take action. We do not disconnect after regular business hours or on weekends.

#### PREPAID CASH CARDS

Walton EMC will never, ever require you to purchase a prepaid cash card to pay any Walton EMC bill or fee. The reason crooks use this method is that you have no recourse once their scheme is discovered – your money is gone.

You can make secure payments by calling us at 770-267-2505, coming by one of our offices, using our convenient smartphone app or going online to waltonemc.com.

Our accepted methods of payment include cash, check, credit or debit card, or automatic draft. We will accept prepaid cards, but we will not instruct you to pay in that manner.

### Avoid Third-party Bill Pay Sites

If you want to pay your electric bill online, simply visit waltonemc.com. There's no need to use a third-party bill pay website.

Other sites, like the one pictured here, charge an extra fee to handle your payment. It's also common for them to delay your payment by days or weeks. If your bill is late because of their delay, you could incur late charges from Walton EMC.

In this case, Google is not your friend. Go directly to waltonemc.com.

Hurricane Damage



The co-op had 116 broken poles scattered across its territory, with the majority being in Gwinnett County. "In my 30-plus years, it's the most I can remember," said Ron Marshall, vice president of engineering and operations.

Replacing a broken pole is the most time- and resource-consuming repair. Just one pole replacement can require several hours and tie up at least two utility trucks.

Power outages affected every corner of the cooperative's 10-county service area. Over 99 percent of customer-owners had power after only 78 hours.

Trees or limbs being blown into power lines by high winds caused all outages.

Visiting crews assisted Walton EMC from as far away as Virginia and as close by as Monroe. Other crews came from Kentucky and North Carolina.

"We greatly appreciate our customer-owners' patience and understanding," said CEO Ronnie Lee. "We know being without power is inconvenient and aggravating. The thousands of kind comments we received by email, social media, phone calls and face-to-face kept us going."

"It's been a total effort by everyone at Walton EMC," said Marshall. "Employees and those assisting us did an impressive job. But, we're never satisfied until every customer-owner is back on.
