Trust Awards \$160,000 in Scholarships

Paying for college will be a little easier for several recent high school graduates who live along Walton EMC's power lines. They are sharing \$160,000 in scholarships awarded by the Walton Electric Trust.

Out of nearly 150 applicants, 32 students are receiving \$4,000 each to help fund post-secondary education at a college or vocational-technical school. Another 28 are the recipients of runner-up scholarships of \$1,000 each. The 2022 winners represent schools from across the co-op's 10-county service area.

Applicants were evaluated on work ethic, triumph over obstacles, community service and extracurricular activities. The scholarship committee also reviewed recommendations from teachers and other adults involved in the students' lives.

The Trust has awarded more than 500 scholarships worth over \$1.9 million since the program began in 2009. The scholarships are funded by unclaimed refunds to former Walton EMC

customer-owners. After all efforts are exhausted to find the rightful owners, the money goes into an endowment provided for by Georgia law.

PLUGGED IN

Q: Who's responsible for keeping limbs off the power line to my house?

A: Walton EMC customer-owners who receive electricity through overhead power lines have a service wire that runs from the utility pole to your home. It's your responsibility to keep an eye out to ensure branches don't become overgrown and touch the service line.

Primary lines carry thousands of volts from the substation to the transformer at your home or business. Service lines carry hundreds of volts from the transformer to the electric meter. The 15-foot clearance for primary lines does not apply to service lines.


If vegetation does make contact with your service line, DO NOT attempt removal on your own. This is extremely dangerous. A common service wire carries 240 volts of electricity - more than enough to kill you if you make contact.

If there are limbs less than six feet from the service wire and are a threat to damaging your service, **call the co-op at 770.267.2505** to request a trim.

A crew will usually arrive within three business days to handle the pruning project. It is the customer-owner's responsibility to clear away the debris resulting from the trim.

'In one moment, my life changed' SCHOLARSHIP RECIPIENT OVERCOMES ADVERSIT

This year's Walton Electric Trust scholarship recipients possess the kind of credentials that typically earn such rewards. They are smart, driven, focused individuals.

But these scholars also exhibit another quality that separates them from the crowd. Each has triumphed over a significant obstacle in their life.

Landon Hagwood is a shining example. He twice battled an aggressive form of bone cancer while attending Oconee County High School.

"On Sept. 23, 2019, I went into Emory Midtown in Atlanta for a surgical biopsy that confirmed our worst fears," the student recalled about the malignant tumor found in his shoulder. "In one moment, my life changed."

Part of his shoulder was surgically removed, which doctors said would severely limit Landon's arm mobility for the rest of his life. At best, he might be able to reach high enough to comb his hair.

With the help of a dedicated physical therapist, he proved them wrong. Now cancer-free, Landon plans to pursue a career inspired by the healthcare provider.

"The work my physical therapist has done with me during my journey has been so impactful and life-changing for my abilities," he said. "I want to do the same for others."

A Walton Electric Trust scholarship will help pay for his college education. Landon promises co-op members it will not be wasted.

"Cancer does not define me, but it has changed the course of how I live my life and what I will accomplish," he said. "I can promise you that I will represent you well in my dedication to my studies and how I succeed in college."



2021 CAPITAL CREDITS

As a member of Walton EMC, you're also an owner. One benefit of ownership in a not-for-profit cooperative is sharing funds remaining after expenses are paid and reserves are met. Every Walton EMC customer-owner has a capital credit account and receives a refund based on the amount of electricity they use.

The co-op's directors assess the financial condition of the co-op to determine when and what amount of leftover funds, called capital credits, can be returned to members after reserves are set aside for capital improvements and emergencies.

Capital Credit Allocation

A capital credit allocation is a record of your investment in the cooperative. \$7,763,404.34 in capital credits were assigned to all customer-owners in 2021.






AVG. MONTHLY RESIDENTIAL/FARM BILL



AVERAGE KWH PER MONTH




AVERAGE NUMBER OF MEMBERS















HOW ELECTRIC REVENUE WAS USED
